Detox implementation overview report: progress report on services and activities

February 2016

- Set up a Detox implementation website for tracking the progress of the tools and processes: <https://www.confindustriatoscananord.it/sostenibilita/detox/english-version>
 - publication of a common reference Detox-standard M-RSL
 - Publication of Initial Wastewater/textile/chemical testing on 11 priority groups of substances for 20 companies on Detox implementation website.
 - Elaboration of the the sampling plan and activities that companies will have to perform on products and formulations in order to verify the compliance on elimination of the 11 groups of hazardous chemicals included in the Detox commitment. The individual results has been published on the companies website. The CTN Environment department coordinate all the activities and the publication of results on individual company websites and create and publish on CTN Detox implementation website a public database of aggregated data.
 - CTN Environment department support and coordinate the disclosure and uploading on the IPE platform of wastewater discharge test results

- Start of the campaign to strengthen the contractual language and agreement with suppliers to ensure that only chemical formulations free from the hazardous chemicals on the MRSL (starting with the 11 priority groups, in particular APEO's) are used. "CTN Environment department" has provided the forms and tools to contact suppliers and reporting back on responses.

June 2017

- Disclosure of traceability program on hazardous chemicals in recycled textiles: presentation and publication of case study on regenerated textile products and Restricted Substances List (PRSL) for Regenerated Textile Product for Detoxed Companies on the Detox implementation website of the CTN.
- Start of collaboration with credible external third party (ICEA) for independent verification & auditing/ certification on regenerated textile products (GRS certification).
- Start of testing campaign for the case study on the use of the perchloroethylene in washing fabric in width.
